I/we understand that, as the Incomer, and once I/we have signed the AECS contract, I/we will be entitled to claim any annual recurrent management grants on the land being transferred if the date of transfer to me/us is on or before 15th May in the year of transfer.

I/we understand that, if the date of transfer is after 15th May in any given year, then the annual recurrent management grant payments, for that year, would be paid to the Outgoer, on the basis that the Outgoer will have claimed the annual management grants in the claim window (which ended on 15th May) and on the basis that the Outgoer will have met the obligations of that annual management payment.
