# **Guidance Notes**

with Annexes 1 & 2



#### **GUIDANCE NOTES**

- For the purposes of this document, an egg packing centre is defined as 'premises where table eggs are
  brought to for grading and packing but does <u>not</u> include premises or part of premises which deals
  <u>exclusively</u> with eggs laid on the same premises'.
- Eggs from premises in a Highly Pathogenic AI (HPAI) protection of surveillance zone or from a Low Pathogenic AI (LPAI) restricted zone moving to an egg packing centre under licence, may only move to a designated egg packing centre.
- Egg packing centres may be designated to receive eggs during an outbreak by an officer representing the Scottish Government.
- The Scottish Government reserves the right to remove an egg packing centre from the list of predesignated or designated egg packing centres if it no longer fulfils or is unable to fulfil the required criteria for pre-designation or designation.
- The information on this form is intended solely for the use by APHA, the Scottish Government and Local Authorities (LAs) in relation to animal disease control, and the application and enforcement of animal disease control legislation. It is not intended for use by any other person or for any other purpose other than for statistical and research purposes. The information may also be disclosed, if required, in accordance with legal requirements.
- Please note that it is your responsibility to be aware of any restrictions placed on your premises or supply farms.

#### Requirements for Approval for Pre-Designation

To qualify:

- You must be registered with the Scottish Government Eggs and Poultry Unit as a fully authorised packing centre.
- This application form must be completed by a person who is responsible for the egg packing centre
   (including the care and control of the eggs while on the premises, the keeping of records in respect of
   eggs entering and leaving the egg packing centre, and the keeping of records in respect of eggs in the
   egg packing centre) which is seeking pre-designation.
- The packing centre/applicant must be able to comply with the terms set out in Annexes 1 and 2.

#### What is the difference between Pre-Designation and Designation?

- To become designated during an outbreak, a premises must meet all conditions and standards as
  required by APHA and the Scottish Government (SG). Designation requires a heightened standard of
  biosecurity in order to reduce the risk of spreading disease. Annex 1 contains the Schedule of
  Conditions of Designation and further guidance on compliance with requirements in an outbreak.
- Pre-designation is a pre-approval process aimed to reduce the processing time for designation during an outbreak. An application for pre-designation can be made at any time, and in order to process it, SG/ APHA inspectors will arrange visit the premises to review and inspect it. They will provide feedback if any changes need to be made in order to meet the requirements. Once a premises is pre-designated then it's status remains valid for a year, unless changes are made to the site or agreed processes, and a pre-designated premises can apply for designation (activation of designation) during an outbreak.

#### **GUIDANCE NOTES**

#### What happens after I submit this form?

- The Scottish Government Poultry Unit (SGPU) and APHA attend the initial inspection of the premises and they will work with you to ensure that the requirements of pre-designation are met.
- Once the official signatories in SGPU and APHA are satisfied, they will approve this application and APHA will send the following to the applicant:
  - 1. a letter confirming that the premises is 'Pre-Designated'
  - 2. a copy of the Application for Designation form, for future use
  - 3. a reminder of the actions that the premises is required and has agreed to take, in order to become Designated (completed by SGPU during inspection)
- You must ensure that you keep a copy of your application form and confirmation documents.
- You are also responsible for requesting the annual renewal of Pre-Designation by contacting Scottish Government's Poultry Unit.

#### Relevant legislation

The Avian Influenza and Influenza of Avian Origin in Mammals (Scotland) Order 2006 and the Avian Influenza (Slaughter and Vaccination) (Scotland) Regulations 2006, (which together transpose European Council Directive 2005/94/EC on measures for the control of Avian Influenza) require controls on the movement of eggs if AI has been confirmed.

#### **ANNEX 1**

### Schedule of Conditions of Designation

#### Detailing structure/ management/procedures in an egg packing centre

- 1. When the egg packing centre is on the same site as live poultry or other captive birds, all staff that work within the egg packing centre itself must not enter any part of the premises (pasture of any houses) in which the birds are present, and staff working with the birds must not enter the egg packing centre. Any person carrying out essential maintenance that requires them to enter both the egg packing centre and the area where there are birds, may do so as long as they observe strict biosecurity standards when moving between the two. (See paragraph A below for further guidance)
- 2. All staff or visitors entering the egg packing centre itself must wear visibly clean overalls. Once worn, the overalls must not leave the egg packing centre, other than for laundering. Footwear worn in the egg packing centre must also be visibly clean. (See paragraph B below for further guidance)
- 3. Facilities must be available on site for the effective cleansing and disinfection of parts of vehicles and equipment used to transport table eggs to or from the designated premises.
- 4. Egg packing trays which have been used to transport table eggs that were laid on premises in a HPAI protection of surveillance zone or in a LPAI restricted zone, must be disposed of in such a way that they cannot be re-used (disposal as waste, recycling).
- 5. If using re-usable plastic trays they must be washed and cleaned using an approved disinfectant and at the required dilution rate, and marked as such.
- 6. An effective tracing system must be established, which identifies where table eggs have come from and will enable the operator to identify egg packing trays which have been used to transport table eggs that were laid on premises in a HPAI protection of surveillance zone or in a LPAI restricted zone.

## Guidance Notes on Compliance with Requirements in an Outbreak

- A) Guidance for compliance with condition of designation (1):
  - the egg packing centre should be laid out, adapted, or clearly marked to ensure that, in an outbreak, there is sufficient separation of staff dealing with any live poultry on the production side and those dealing with the grading of eggs in the main packing centre. In general, staff should not work in both areas.
  - where it is absolutely necessary for staff or visitors to move between poultry production areas and packing areas, they <u>must</u> change all outer clothing and footwear and wash their hand before moving across
- B) Guidance for compliance with condition of designation (2):
  - the egg packing centre must have a sufficient supply of new or properly laundered overalls available for staff in the event of confirmation of designation. Supply must be able to meet demand, so that new of clean overalls are always available. For example, where laundering is done twice per week, there must be sufficient clean or new overalls for all staff of wear for at least three to four days.
- C) Guidance on cleansing and disinfection of vehicles:
  - as well as cleansing internal areas of the vehicle used to transport eggs, egg packing centres are advised to ensure that wheels and arches are cleansed and disinfected.

#### **ANNEX 2**

#### **Movement Restrictions**

This document describes the basic restrictions that are likely to be applied for the movements of table eggs **from** the controlled zones in an outbreak of avian influenza. If your premises falls within any controlled zones during an outbreak, you should check the precise controls that apply to you.

Different controlled zones and different levels of restriction apply to Low Pathogenic Avian Influenza (LPAI) and High Pathogenic Avian Influenza (HPAI).

Egg producers and packing centres should be aware of these differing restrictions.

It is important to note that this system is open to change and may need to be revised in the face of the circumstances at the time of any outbreak.

In most cases, movements of table eggs will be permitted under general licence which will be published on the Scottish Government website.

#### **ANNEX 2a**

#### Conditions for the movement of table eggs from premises in a:

- a. Highly Pathogenic Avian Influenza (HPAI) protection zone—(under title 'General Licence A')
- b. Highly Pathogenic Avian Influenza (HPAI) surveillance zone—(under title 'General Licence A')
- c. Low Pathogenic Avian Influenza (LPAI) restricted zone—(under title 'General Licence')
- i) The move must be direct to the premises of destination;
- ii) The premises of destination must be:
  - · premises designated by the Scottish Ministers as an egg packing centre
  - premises for the manufacture of egg products in accordance with Chapter XI of Annex II to Regulation (EC) No. 852/2004; or
  - premises for disposal in accordance with the Animal By-Products (Enforcement) (Scotland) Regulations 2011
- iii) Eggs moving to the permitted designations listed above, must be packed:
  - in new disposable packaging or plastic trays which have been washed and cleaned using an approved disinfectant and at the required dilution rate
  - · onto clean pallets or containers; and
  - in an area which must be free from visible contamination with mud, slurry, animal faeces, excretions or any other similar matter
- iv) Before entering or leaving the premises where eggs are loaded:
  - the exterior of the vehicle must be free of any visible contamination with mud, slurry, animal faeces, excretions or any other similar matter; and
  - the vehicle's wheels and wheel arches must be cleansed and disinfected after loading. The cleansing and disinfection must take place at a point beyond which no contamination with poultry feathers, faeces, litter, egg shell or any similar matter can take place
- v) After unloading at the premises of destination:
  - in the case of a premises designated as an egg packing centre, the parts of the vehicle and any other
    thing used to transport eggs to the egg packing centre which might be contaminated with feathers,
    faeces, litter, egg shell or visible contamination with broken egg or any similar matter must be cleansed
    and disinfected, as soon as is reasonably practicable, on the packing centre premises. In the case of
    movements from LPAI restricted zones, the cleansing and disinfection of the vehicle, or other things, may
    be carried out elsewhere, but must be carried out as soon as practicable and before the next use of the
    vehicle or thing.
  - in the case of premises for the manufacture of egg products, the cleansing and disinfection should
    preferably take place on the premises, but may be done elsewhere. This should be done as soon as
    reasonably practicable and, in any case, before the vehicle is used again
  - in the case of a premises for disposal, the cleansing and disinfection must take place as soon as reasonably practicable and, in any case, before the vehicle is used again
- vi) All persons to whom this licence applies shall:
  - not enter or leave premises wearing clothing or footwear which is visibly soiled with mud, animal or bird faeces or any similar matter
  - cleanse and disinfect their footwear on leaving premises within the controlled zone; and
  - · take all other reasonable precautions to avoid the transfer of contamination between premises

#### Additional Note—Movements:

The person moving anything under the authority of a general licence granted under the Order, must carry with them, at all times during the licenced movement, a consignment note containing details of what is moved, including:

- its quantity
- · the date of the movement
- · the name of the consignor
- · the address of the premises from which the movement started
- · the name of the consignee; and
- · the address of the premises of designation

On demand by a Veterinary Inspector (VI) or other officer of the Scottish Ministers, the person moving anything under the authority of a general licence must produce the consignment note and allow a copy of extract to be taken, and on such demand must provide their name and address.

#### **ANNEX 2b**

#### Conditions for the movement of table eggs from premises in a:

- a. Highly Pathogenic Avian Influenza (HPAI) restricted zone—(under title 'General Licence B')
- i) Eggs must be packed;
  - in packaging (including plastic keyes trays) which is free from feathers, faeces, litter, eggshell or visible contamination with broken egg
  - · onto clean pallets or containers
  - in an area which is clear of visible contamination from mud, slurry, animal faeces, secretions or any other similar matter
- ii) Before entering or leaving the premises in the HPAI restricted zone:
  - the exterior of the vehicle must be free of any visible contamination with mud, slurry, animal faeces, excretions or any other similar matter; and
  - the vehicle's wheels and wheel arches must be cleansed and disinfected after loading. The cleansing and disinfection must take place at a point beyond which no contamination with poultry feathers, faeces, litter, egg shell or any similar matter can take place
- iii) After unloading at the premises of destination:
  - in the case of a an egg packing centre (which does not have to be designated), the parts of the vehicle
    and any other thing used to transport eggs to the egg packing centre which might be contaminated with
    feathers, faeces, litter, egg shell or visible contamination with broken egg or any similar matter must be
    cleansed and disinfected, as soon as is reasonably practicable, on the packing centre premises.
  - in the case of premises for the manufacture of egg products, the cleansing and disinfection should
    preferably take place on the premises, but may be done elsewhere. This should be done as soon as
    reasonably practicable and, in any case, before the vehicle is used again
  - in the case of a premises for disposal, the cleansing and disinfection must take place as soon as reasonably practicable and, in any case, before the vehicle is used again
- iv) Packaging (including plastic keyes trays) may only be re-used if:
  - it is free from feathers, faeces, litter, eggshell or visible contamination with broken egg
  - it has been washed and cleaned using an approved disinfectant and at the required dilution rate, and marked as such.
- v) All persons to whom this licence applies shall:
  - not enter or leave premises wearing clothing or footwear which is visibly soiled with mud, animal or bird faeces or any similar matter
  - · cleanse and disinfect their footwear on leaving premises within the controlled zone; and
  - take all other reasonable precautions to avoid the transfer of contamination between premises

#### Additional Note—Movements:

The person moving anything under the authority of a general licence granted under the Order, must carry with them, at all times during the licenced movement, a consignment note which contains details of what is moved, including:

- · its quantity
- · the date of the movement
- · the name of the consignor
- · the address of the premises from which the movement started
- · the name of the consignee; and
- the address of the premises of designation

On demand by a Veterinary Inspector (VI) or other officer of the Scottish Ministers or by an inspector, the person moving anything under the authority of a general licence must produce the consignment note and allow a copy of extract to be taken, and on such demand must provide their name and address.
