


Unauthorised products include:


- Imported products that do not have a trade permit for use in the UK;
- Product authorisation has lapsed or has been revoked;
- Product labels not in English (excluding parallel imports);
- Banned pesticides e.g. poisoning incidents.
- 2 Have the products been used in accordance with the conditions detailed on the product label, in the authorisation, permit or in any extension of use?



Examples of breaches include:

- Products not authorised or permitted for use on the crop, land or situation;
- Products not authorised for method of application;
- Max. dose/concentration exceeded;
- Max. number of applications exceeded;
- Application dates/harvest intervals not observed.
