## Introduction

A new element in the Agri-Environment Climate Scheme is that many management options and some capital items have been spatially targeted.

This means they will only be available in parts of the country where they will deliver the greatest benefit.

You can find out which options are available on your holding using our targeting tool.

### [Targeting](#)

The decision-making process for the spatial targeting will be published on the Rural Payments and Services website later in 2015. The approach to spatial targeting will be reviewed at the end of 2015 and revisions to targeting maps will be considered for the 2016 application period.

In exceptional circumstances, you may apply for a management option or capital item that is not targeted on your holding. However, your application must meet the criteria for endorsement outside the target area.

For the 2015 application period, endorsements for options outside target areas are restricted to well-justified applications for those management options and capital items specified in Table 1 (below).

Requests for endorsements should be made to Scottish Natural Heritage, Forestry Commission Scotland or SEPA, depending on the management option or capital item concerned.

### **Natural heritage designated sites**

These include Sites of Special Scientific Interest, Special Protection Areas and Special Areas of Conservation.

If you wish to carry out management to benefit an SSSI and / or Natura site, you can apply for any management options (with the exception of the Hen Harrier Grassland Management option which is only available in Orkney) or capital items which will benefit the special features of the site, even if they do not appear on your list of targeted options.

This includes circumstances where the work that will benefit the site's features takes place on your holding but partially or wholly outside the site itself.

You will need to submit an endorsement from Scottish Natural Heritage with your application. This needs to confirm that the option or capital item you have chosen will benefit the features of the designated site.

You can visit the Scottish Natural Heritage website to check the location of the designated site.

We would advise you to seek advice from Scottish Natural Heritage before drafting an application for a designated site, especially if you are uncertain how your proposal may affect the site.

## Application process

If you wish to apply for an endorsement then you must submit a request to Scottish Natural Heritage, Forestry Commission Scotland or [SEPA](#) and ensure that the endorsement is submitted together with your application.

Check Table 1 below to see whether the management option or capital item you wish to apply for this year is listed and to check which organisation to contact. Only those management options or capital items listed in Table 1 will be considered for endorsement.

In seeking an endorsement you will need to meet the criteria specified for each management option or capital item listed. Scottish Natural Heritage, Forestry Commission Scotland or SEPA will clarify whether you need to provide any further evidence.

However, in most cases the endorsement will confirm that the options you have selected are eligible, will benefit the objectives of management and that the location in which you wish to carry out the management is appropriate.

In your application, you will also need to provide a justification that the management option or capital item that you are proposing can deliver the benefits expected under that management option or capital item in the target area.

### Table 1

Management option or capital item	Criteria for endorsement outside target areas	Endorsing organisation
Management, restoration or creation of hedgerows	The hedgerow has been created under a legacy agri-environment scheme (this applies only to the management and restoration of existing hedges and not hedgerow creation)	SNH
Unharvested conservation headlands for wildlife	Presence of corn buntings according to existing records	SNH
Moorland management Stock disposal Away wintering sheep Summer hill grazing of cattle	Presence of a habitat on your holding that would benefit from management under one or more of these options, including blanket bog and wet heath	SNH
Tall-herb vegetation management	Presence of tall herb vegetation which would benefit from management under this option	SNH
Control of invasive non-native plant species	The land on the holding is part of an area-wide, coordinated strategy for controlling invasive plants, or you are first land manager in your area to have the plant species on your land	SNH
Wild Bird Seed for Farmland Birds	This management option is undertaken in Orkney	SNH

Rhododendron control	The land on the holding is part of an area-wide, co-ordinated approach for controlling a whole population of rhododendron; and work is essential to control or prevent invasion of a notable site (Special Area of Conservation, Site of Special Scientific Interest or ancient semi-natural woodland site); and/or necessary to secure another investment in controlling a population of rhododendron	SNH/FCS
Retention of winter stubbles for wildlife and water quality Beetlebanks Grass strips in arable fields Water margins in grassland fields Converting arable at risk of erosion or flooding to low-input grassland Managing steading drainage and Rural Sustainable Drainage Systems Pesticide handling facilities Hard standings for troughs and gateways Livestock tracks Rural Sustainable Drainage Systems – Sediment Traps and Bunds Rural Sustainable Drainage Systems – Swales Rural Sustainable Drainage Systems – Retention Pond	The holding is located within a Diffuse Pollution Priority Catchment or Focus Area (for example, as a result of new Priority Catchments and Focus Areas introduced after the target maps for these options were defined).
